PLEASE READ THE FOLLOWING:

FVR will not be responsible in any way to those who fail to attend their regularly scheduled sessions. No refunds will be issued due to absences or failure to attend programs. All instructors are professional working actors/directors and because of this, instructor/schedule changes may occur. By enrolling by mail the Student/Parent/Guardian states: "I am not allergic to cosmetics nor do I have any other condition which would limit my participation in the programs. I hereby assume all risk of allergic reaction to cosmetics and of injury and damage resulting from my training at the FVR, and I hereby release FVR of and from all claims resulting from any such allergic reaction and from any personal injury or damage which I may sustain as a result of my training.

I hereby authorize, in perpetuity, FVR and its assignees to use my photograph(s), video(s) and/or attributed testimonials in the ordinary promotion of the FVR. I also authorize non-commercial use of my photos, image, videos and testimonials as personal advertisement for the photographers' and instructors' professional services, including but not limited to Internet sites." FVR will charge a \$50.00 fee if a check, negotiable order of withdrawal, or share draft is returned for insufficient funds. Parking can sometimes be a challenge. You may park in Valet Parking in front of the theater. On Fridays and Saturdays, cars must be moved by 3:30 pm. In addition, you may park on the other side of Route 64 in the lot and cross at the traffic light. If you are only dropping off, you may park in front of the main entrance of the resort for a few minutes while you take your child to class.

- We ask that parents do not stay for classes. It makes children self-conscious, and they will look continuously for approval instead of focusing on what the class is doing.
- ALWAYS bring bottled water labeled with name. There are no water fountains.
- Feel free to bring snacks as long as they are secure. Snacks and meals may be purchased at the Terrace Café or Thieves' Market located in the resort.
- Do NOT bring snacks containing nuts. Please check the ingredients.
- NO GUM!
- NO FLIP FLOPS. Closed shoes only; sneakers, jazz or ballet shoes are preferred.
- Students are expected to rehearse and memorize lines at home.
- No skirts/dresses unless shorts are worn underneath.
- Always bring a sweater/sweatshirt.
- Please make sure your child uses the restroom **before** class.
- It is very important that students make all classes so they do not fall behind and can perform to the best of their ability.
- Please notify your instructor if you cannot make a class by contacting them.
- All classes and showcases have been scheduled. Please check your calendar and advise immediately if you have any conflicts. We cannot change dates or times.
- Please show respect for everyone by being on time to all classes and performances.
